**\* Article 93(3) of the Act of 20 July 2018 – Law on Higher Education and Science:**

The benefits referred to in Article 86(1)(1–4) and Article 359(1) of the Act – Law on Higher Education and Science shall not be granted to a student who holds a professional degree of master (*magister*), master engineer (*magister inżynier*) or equivalent, bachelor (*licencjat*), engineer (*inżynier*) or equivalent, if he or she is undertaking first-cycle studies once more.

**Article 93(4) of the Act of 20 July 2018 – Law on Higher Education and Science:**

The total period during which the benefits referred to in Article 86(1)(1–4) and Article 359(1) are granted shall be 12 semesters, regardless of whether the student actually receives them, provided that within this period the benefits are granted for the following studies:

- 1) first-cycle studies – for no longer than 9 semesters;
- 2) second-cycle studies – for no longer than 7 semesters.

**\*\* Article 93(2) of the Act of 20 July 2018. Law on higher education and science:**

Students studying simultaneously in more than one field of study may receive the benefits referred to in Article 86, section 1, subsections 1-4 and Article 359, section 1 (maintenance grant, scholarship for disabled persons, financial aid, rector's grant and minister's grant) only in one field of study indicated by them.
